Undergraduate Lecture Courses

"Economy and Society." This is a course in historical sociology taught in five parts: pre-capitalist societies, the transition from feudalism to capitalism in Europe, the Industrial Revolution in Britain, the world system in the twentieth century, the USA since 1945. The perspective derives from Weber and Polanyi.

"Urban Sociology." This is a course in historical sociology of cities taught in correspondence with my *Cities in World Perspective*. Perspective of the course is institutional, historical, and comparative with much emphasis upon immigration and ethnicity.

"Entrepreneurship." Developed by me, this course requires Economy and Society as a prerequisite. Only partially historical in approach, it treats the following subjects: Weber's theory of entrepreneurship, Paul Wilken's theory, social capital, transaction costs, population theories, ethnic and immigrant entrepreneurs, women entrepreneurs, illegal entrepreneurs, socialist entrepreneurs, entrepreneurial solutions to social problems, politics of entrepreneurship.

"Comparative Immigration." This course compares the European New Immigration of 1880-1920 with the Asian and Latino new immigration since 1965.
